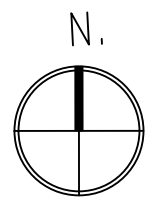

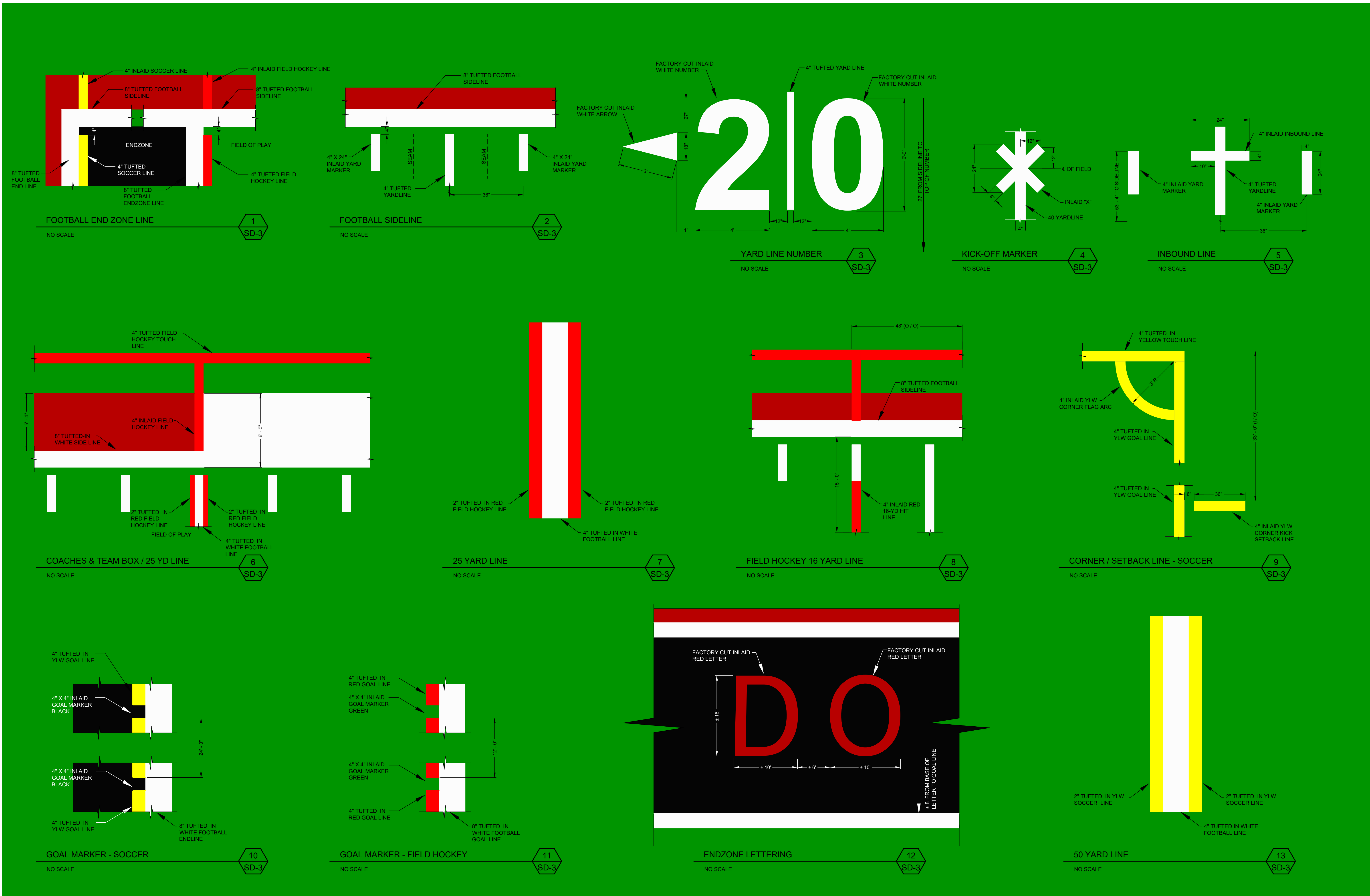

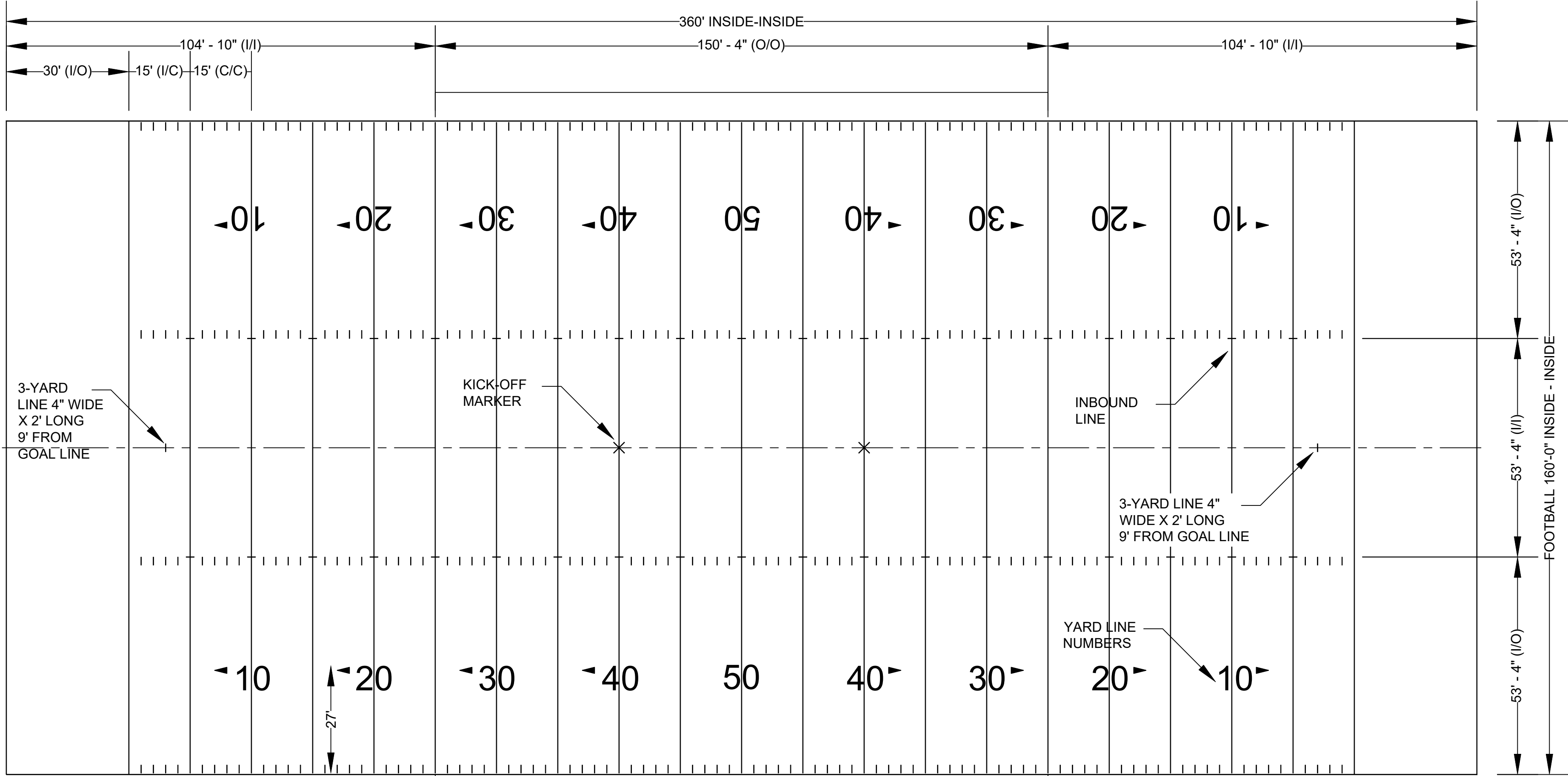

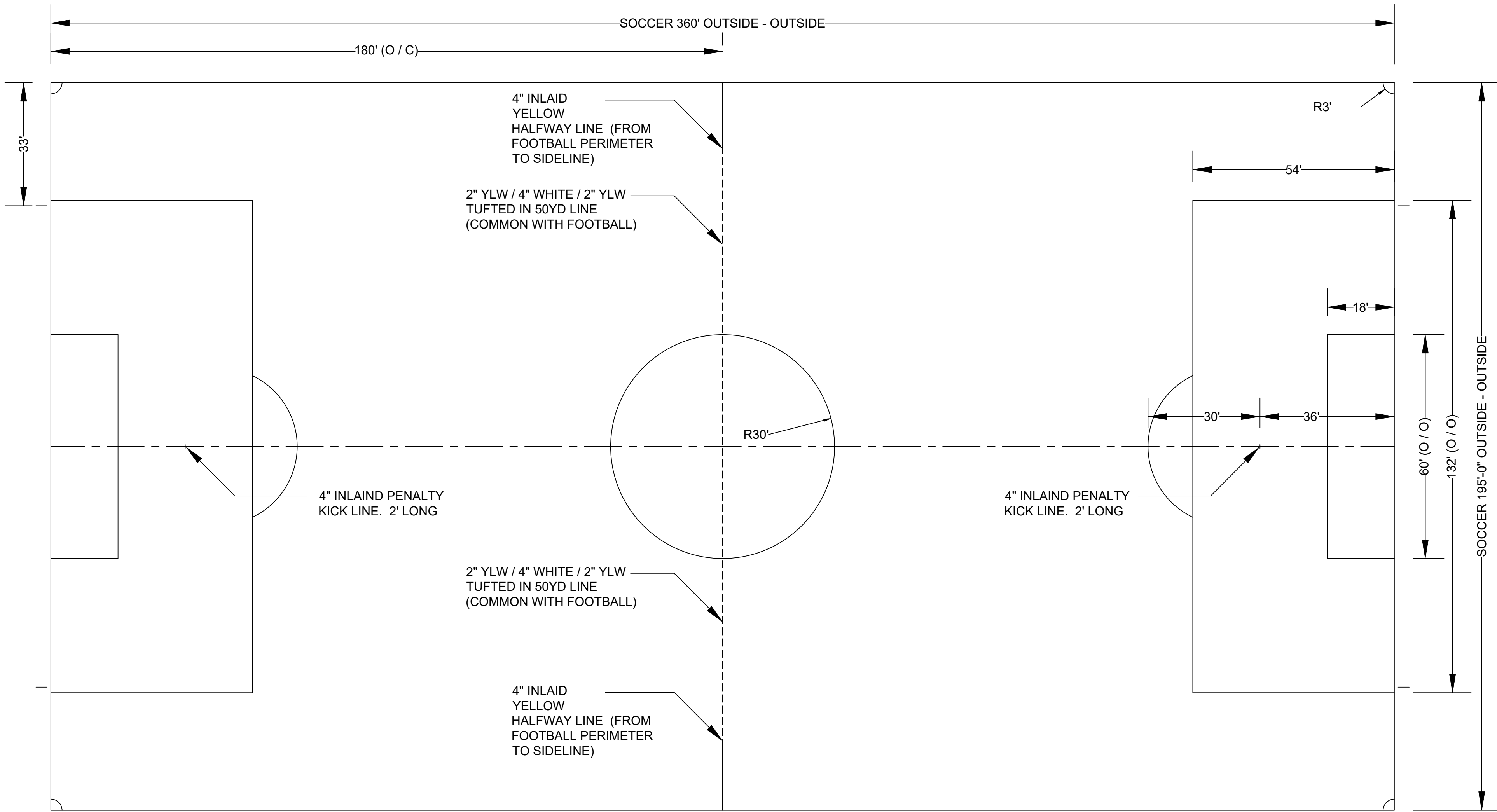

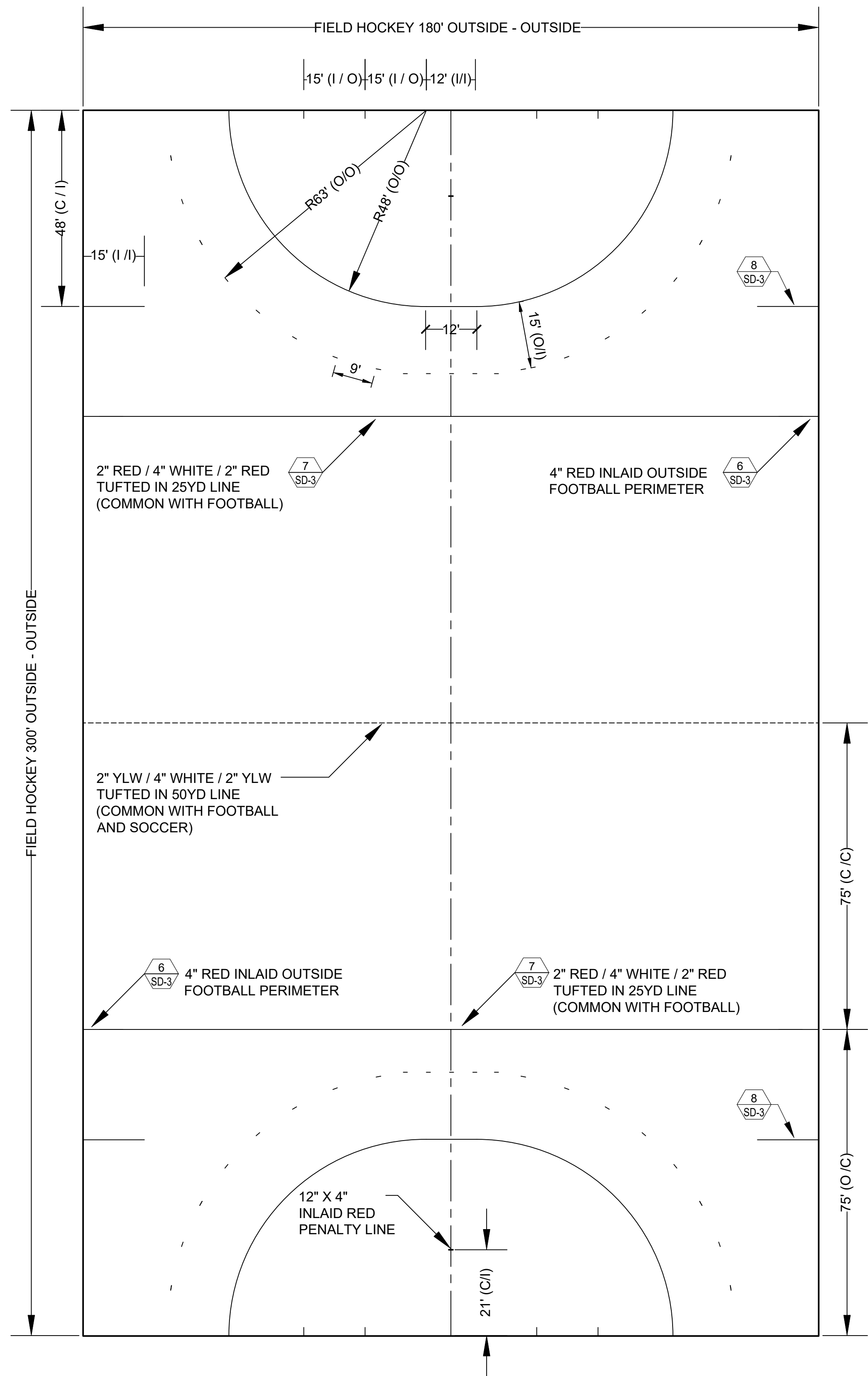
FOOTBALL LAYOUT PLAN

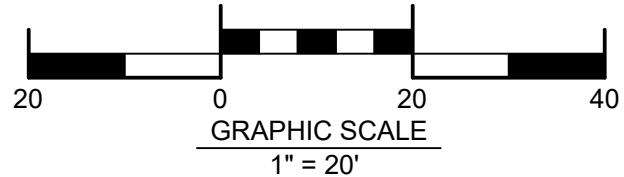
SOCCER LAYOUT PLAN
